

## Cuppa For CANSA – Hostess Competition

### TERMS AND CONDITIONS

2. The promoter is The Cancer Association of South Africa (CANSA)
3. The promotional competition is open to all South African residents who are over the age of 18 years and in possession of a valid identity document, except any director, member, partner, employee, agent or consultant of the Promoter, the marketing service providers or any person who directly or indirectly controls or is controlled by these entities, including their spouses, life partners, business partners or immediate family members
4. This competition is open from June 2018 and nominations will close at midnight on 31 October 2018. Any entries received after the closing date will not be considered.
5. Any director, member, partner, employee, agent or consultant of the Promoter, the Sponsors or Associates, or any person who directly or indirectly controls or is controlled by these entities, including their spouses, life partners, business partners or immediate family members are not allowed to enter.
6. Entry into the Cuppa For CANSA Hostess competition is free.
7. Entrants will be required to host a Cuppa For CANSA event according to the guidelines stipulated in the CANSA's Fundraising Guide, which will be provided to you. Adherence to these guidelines is essential and any nominee not adhering to these guidelines will be disqualified.

9. The best Cuppa For CANSA event per region will be selected and will receive a Hamper from our brand partners. The judges' decision is final and no correspondence will be entered into.
10. Winners of the Prizes will be notified via the contact details provided by the winner in entry form (used for entry of the competition) by sending an email notifying them that they are a winner, where after the winner will be required to verify their details. The Promoter (or their agent) will endeavour to contact the prize winner once every day for 7 consecutive working days after their name is selected (via e-mail/Facebook/phone). If the prize winner cannot be contacted during this period, the prize will be forfeited and another winner will be selected in accordance with the rules.
11. Prizes in the form of goods include delivery and winners will be required to provide the Promoter with a valid day time address to enable delivery.
